Committee Updates

UNDERWRITING **COMMITTEE**

AML Compliance

Committee Chairperson Dyan Loutan-Ali met with the Chairperson of the Fraud, Regulatory and Anti-Money Laundering and Com-Committee pliance Prabha Siewrattan, to discuss how the Underwriting Committee can be of assistance in getting the drafted form on Customer Due Diligence Checklist for Individual Policyholders implemented. form has been circulated to the Underwriting Committee members for comments and feedback.

Information Sharing Proposal Clause on **Forms**

The Committee has agreed to a draft declaration that can signed by clients as part of the proposal form.

Fraudulent Motor Certificates

ATTIC is awaiting details on the number of ATTIC's Vice President fraudulent motor certificates identified by ris and Director member companies.

Non-Payment of Premiums

Committee members have decided to review their individual wordings for non-payment of premiums, so that a standard industry wording can be formulated.

CLAIMS COMMIT-TEE

Subrogation line

A three-person committee has been appointed to make suggested changes to include timeframes outlined in the draft Insurance Bill and to review comments received by the Central Bank.

Claims on Government Owned Vehicles

Committee members agreed to collate outstanding claims from the Government over the past four years, to lobby the Government and the CBTT for resolution for insurers and third parties.

LIFE COMMITTEE

Annuities at the BIR

A compilation of outstanding policies was forwarded to the BIR in 2010. To date no feedback has been received.

Guide- Full Commutation **Pensions**

The Committee is still awaiting the formal documentation from the BIR.

Policies Returned from the BIR

The BIR issued a list to companies insurance highlighting the reasons why policies are returned. Members of the committee disagreed with some of the items listed. A letter has been drafted to be sent to the BIR indicating these issues.

Occupational Pensions Act

ATTIC's V.P. Life, James Camacho provided comments to the Central Bank on behalf of the Insurance Industry. CBTT is currently reviewing all of the comments that were received from various

stakeholders and they are expected to provide another Policy Proposal Document at the end of this year.

HEALTH PROVID-ERS COMMITTEE

Reasonable and Customary Schedules

The Committee is still in the process of pooling together their individual company R&C listings to formulate a collective list.

Meeting with the Private Hospital Board

The Committee met with Dr. Anton Cumberbatch in February 2011, where they were able to have a question and answer session to clarify several issues.

Ouestionable and Fraudulent Database

The Committee has put this on hold until furinformation gathered from legal personnel, in order to ensure that there would be no breach of confidentiality.

Working with Stakeholders

Ministry of Labour

The Ministry of Labour has started meetings with stakeholders on the repeal and replacement of the Workmen's Compensation Act. David Lee-A-Ping, Vanetta Bissondatt and Ramnarine Mungroo represented ATTIC.

Decade of Action

Following the launch of the Decade of Action for Road Safety by Arrive Alive, both the Ministry of Works and Transport and the Ministry of Health have instituted separate initiatives. Nivash Persad and David Lee-A-Ping are representing ATTIC on the committee headed by the Ministry of Works. Sonia King is representing ATTIC on the Ministry of Health's committee.

Capital Adequacy

ATTIC and the Central Bank hosted a half-day session on Capital Adequacy for General Insurers on April 5th 2011. Members learned about the assessment of outstanding claims, triangulations and the development of loss ratios. The CBTT also shared their review methodology for the B4 Claims Schedules. ATTIC and the CBTT will be co-hosting training for persons at various companies who prepare these schedules on May 27th, June 1st and 2nd 2011.

Board of Inland Revenue

ATTIC's Vice President-Life, James Camacho, shared ATTIC's various concerns with the Board of Inland Revenue, at a meeting held for stakeholders on April 27th 2011.

Promoting Careers in Insurance

For the first quarter of 2011, ATTIC and the TTII have visited Aranguez North Secondary School and Diego Martin Central Secondary School, to promote careers in insurance.

ATTIC and participants of the TTII's Young Insurance Professionals programme, Nicole Sammy-Daniel, Susan Wright and April Rahaman, also participated in the University of the West Indies' World of Work, promoting insurance as a preferred career option.

National Financial Literacy Exposition
