## **Committee Updates (Committees will Resume Meetings in February 2012)**

### **Health Committee**

- The committee continues to liaise regularly with the relevant authorities for example the Medical Board to clarify cases of questionable doctors and their specialty.
- In order to assist in processing claims effectively the committee requests a registered listing from the Medical Board, Dental Council, Pharmacy Board, and Physiotherapist annually.
- In 2011, the committee also met with various health organizations including Telesalud, Island Sleep Diagnostic and Medic Link Consultants, all in an effort to keep abreast of the new technology and the different avenues that are available. In addition, to the health organizations, the committee also met with Dr. Anton Cumberbatch, Chief Medical Officer at the Ministry of Health to discuss a number of concerns which were brewing.

### **Industry Statistical Report 2010**

Draft statistics representing the General, Life and Health Insurance Industry have been forwarded to each member company for review to ensure accuracy of the data and we look forward to receiving feedback from all members.

### **Claims Committee**

- In 2011, the claims committee worked on revising and making edits to the draft Subrogation Guideline. The guideline is now awaiting approval from the ATTIC Board.
- The committee also compiled a list of recorded stolen vehicles for the period 2005 to 2011 and has forwarded this to the Stolen Vehicles Squad in an aid to allocate or recover some of the vehicles.

### **National Building Code**

ATTIC is represented on the preliminary committee to discuss the drafting of the National Building Code for Trinidad and Tobago. This committee is spearheaded by the Trinidad and Tobago Bureau of Standards in collaboration with UWI Seismic Research Center.

### **Life Committee**

James Camacho, Vice President - Life made a presentation in October 2011 at a BIR Workshop. His presentation highlighted Life Committee concerns particularly, the backlog of annuities awaiting approval at the BIR and commutation of pensions. This was in an effort to receive an ear on these issues so that there can be resolution to long standing matters.

## ATTIC 45th Anniversary & Awards

In celebration of its 45th Anniversary in 2011, the Board of Directors established an annual Long Service Award to recognize the contributions of persons who have participated in ATTIC's various committees throughout the years and helped ATTIC achieve its goals.

## Upcoming Meetings

ATTIC's Executive in collaboration with the Bankers' Association of Trinidad and Tobago (BATT) will be meeting with the Institute of Chartered Accountants of Trinidad and Tobago (ICATT) in an initiative to enhance the efficiency of Financial Reporting in Trinidad and Tobago on February 15th 2012.

## Insurance Education

### **CII Pilots New Experience-Based Assessment Method**

The CII has launched a new assessment method that allows candidates to utilise their previous experience to achieve an Advanced Diploma in Insurance (ACII).

The Advanced Diploma in Insurance demonstrates an applied level of learning and the experiential prior learning route is only suitable for experienced practitioners operating at senior executive level as it based on recognition of prior learning.

The premise is that the candidate already has the level of insurance knowledge required for the Advanced Diploma in Insurance. The CII takes into account candidates' previous qualifications and evidence from their day to day work, roles and responsibilities. These combine with a verbal assessment and are used to assess whether the candidate has reached Advanced Diploma standard.

The experiential prior learning route involves two stages of assessment by the CII:

1. Assessment of the candidate's application.
2. A half day assessor interview where candidates will be individually assessed by an independent assessor on specific learning outcomes.

Successful completion results in an award of the Advanced Diploma in Insurance.

## Robert Ng Chow Chairman of COLFIRE Retires



Mr. Robert Ng Chow retired as the Chairman of COLFIRE on Tuesday 17th January 2012 after twenty eight (28) years of service. Mr. Ng Chow has been a Fellow of the Life Management Institute since 1974 with two (2) specialties, he is also a Fellow of the Chartered Insurance Institute since 1976 and carries the designation Chartered Insurer. He was the first Trinidadian to obtain both designations. He has passed 22 examinations in Life, General Insurance and Management, many with distinctions. Robert Ng Chow has over forty-six and a half (46½) years' experience in the insurance industry.

At the beginning of his career, he spent eight (8) years with a major Global Re-insurer in Toronto, Canada, where he worked and managed the Corporate Actuarial Department. On returning to Trinidad, he held several senior positions within the insurance industry and served as:

- Secretary-General of the Insurance Association of the Caribbean (IAC),
- Past General Manager of TATIL Life,
- Chairman of the Management Committee of the Academy of Insurance,
- Committee Member of the Insurance Association of the Caribbean, and President of the Trinidad and Tobago Insurance Institute.
- He was the recipient of the Gold Award - the highest honor of the Trinidad and Tobago Insurance Institute

He served also as a Director of Flavorite Foods Limited and was a Member of the Board of Governors of the Academy of Insurance.

In 2011, Mr. Ng Chow was instrumental in facilitating the visit of Mr. Nick Plastow- Operations Manager, of the Chartered Insurance Institute (CII) of London to Trinidad to conduct a CII Examinations Workshop to assist persons pursuing the professional insurance designation.

Robert Ng Chow has played an integral part in the development of COLFIRE's numerous innovative insurance products and services and also in the change of COLFIRE's image from just a Fire/Property insurer to being the leading Private Motor Vehicle insurer in Trinidad and Tobago as well. This was done through the development of COLFIRE's many niche motor products, one of which is "The Female Driver's Plan".

Under his leadership, COLFIRE grew in Market Share in Private Motor Insurance and Shareholders Funds have moved from a deficit of TT\$4 million to a surplus of over TT\$100 million.
